# **Japantown SafeCity Program** 2nd Phase Completed and Moving on to Phase 3!

The AVS team has been making steady progress per the JCBD Implementation Plan.

Here's a status update consisting of completion of Phase 2, planning for Phase 3 and other program updates.

- 1. AMC Kabuki Theater and Kimpton Buchanan Hotel installations completed. A total of 23 Camera views have been added to the network for a total of 46.
- 2. Video Control Center has been set up at the JCBD office. JCBD staff underwent training for retrieval process. Orientation for SFPD Northern Station and SIT team to get acquainted with the camera program and the process will be scheduled.
- 3. Network footage has been used by SFPD in their investigation.
- 4. Phase 3 consists of Kinokuniya Building and Japan Center Mall East and West. Completion of Phase 3 will constitute approximately 75% coverage of the JCBD proper area.
